 - All ICS 300 and 400 courses statewide are listed under consistent MI-TRAIN course IDs:
 - [ICS-300 - course ID: 1029037](#)
 - [ICS-400 - course ID: 1029045](#)
 - State offerings of ICS 300/400 are open to anyone to attend at no cost. Travel is not covered. Three ICS 300 courses and two ICS 400 courses are offered by the State each year.
 - Costs to host ICS 300/400 locally through MSP averages from \$2,500 - \$3,500 depending on location. Costs vary at the local level for ICS 300/400 courses not coordinated through the State, as jurisdictions can contract directly with instructors. Local jurisdictions can use anyone on the [MSP approved instructor list](#).
 - Staff attending ICS 300/400 trainings should not incur any costs for taking the courses beyond travel and if meals are being offered.
